

TRNC VISA EXEMPTION CHECKLIST FOR (MEDICAL PURPOSE)

Please note that below list of all documents is mandatory to apply for visa exemption letter only on Pakistani passport and for those who have Preapproval from the Turkish Republic of Northern Cyprus Ministry. All original documents and a photocopy set (Only on A4 size) are required for submission in person by applicants at their nearest Anatolia visa application centres located only at Lahore, Karachi and Islamabad without prior appointment during working days. Personal appearance of the Applicants under 12 years of age is not required.

1.	Visa Application Form (VAF) duly filled and printed at Anatolia Visa Application centres in accordance with the information provided by the applicants with recent two coloured photos attached to it (White Background - 50mm X 60mm size) For photographs specifications, kindly visit our website. Printed VAF should be checked and signed by the applicant (As per passport signatures).	
2.	Pakistani passport should be valid for at least one year from the travel date. Applicants must bring all original passports, current and all previous passports. If any previous passport is lost, a copy of the F.I.R. in English is required. The F.I.R. must be attested by the MOFA (Pakistan Ministry of Foreign Affairs).	
3.	Passport with single name is not acceptable. Applicant sur name and given name including current valid Passport number should be same on all documents. Any discrepancies or variations in names will not be accepted.	
4.	Those cases, where the last digit of the passport number may change due to the issuance of a new passport. In such situations, if the passport number or details do not match those stated in the Ministry-approved document, a new Ministry-approved document will be required. The details in all submitted passports must exactly match the information provided in all Ministry-approved as well as in police character certificate documents.	
5.	Original Police Character Certificate is required which should be attested by the MOFA (Pakistan Ministry of Foreign Affairs) and valid up to 06 months. Police Character Certificate must be issued for Turkish Republic of Northern Cyprus or to be mentioned as Abroad or Visa purposes.	
6.	Valid readable National identity card photocopy on A4 size page (Front and back).	
7.	Original typed/computerized one page signed (A4 size) cover letter on plain paper is required from applicant mentioned about purpose of stay with solid reasons. If applicant has a business, cover letter is required on business letterhead.	
8.	Proof of income (Employment Letter / Sponsorship Letter) is required according to income circumstances. Employment Letter (not older than one month at the submission date) should be written on the company letterhead or stamp paper in English, duly signed and stamped by the relevant official authority.	
9.	Original Bank Account Maintenance Certificate and Original Bank Statements of the Last six Months are required, which are dully signed and stamped by the relevant bank authority.	
10.	MEDICAL HISTORY is required including all previous treatment documents (e.g. prescriptions and lab reports etc.).	
11.	Confirmed paid return FLIGHT BOOKING COPY is required	
12.	ACCOMMODATION LETTER from the hospital for the duration of stay in the Turkish Republic of Northern Cyprus. (if accommodated in the hospital). In case the applicant would like to stay at the accommodation of a relative; permission of the landlord approved by a notary and an invitation letter by the relative is required. In case of hotel stay, paid hotel booking is required which should be according to the confirmed air ticket. The hotel complete address must be written with "Northern- Cyprus".	
13.	Original FRC (Family Registration Certificate) attested by MOFA (Pakistan Ministry of Foreign Affairs). If applicant is married FRC is required with spouse and/or children. If applicant is single/unmarried FRC with parents or/and siblings is required. In case if applicant is married and there is a sponsor person and the sponsor person is spouse or children than the applicants FRC is required with spouse and children only. If sponsor person is one of the parent or siblings, then both FRC from applicant are required with parents/siblings and with spouse/children. In case if the sponsor person is distant family member or friend the sponsor's valid readable National Identity Card (CNIC) copy is required on A4 size page (front and back).	
14.	In case an applicant has a sponsor, an affidavit letter from the sponsor on a notarized stamp paper is required (with a valid CNIC Copy) along with any proof of income (like a Business Letterhead / NTN/last year Tax Returns/Rental or Sale deed/latest Employment letter/ last salary slip/ Retirement/Pension/Foreign Remittance etc.). Sponsors Original bank statement of Last 06 months and account maintenance certificate duly signed and stamped are required.	
15.	If the sponsor is living abroad, the sponsorship letter should be attested by either diplomatic Mission of Pakistan or relevant organizations where sponsor is working or Notary from any legal firm (with a valid ID Copy, Name, Passport number must be correct and should be typed, manual writing/editing is not acceptable.)	
16.	Minor (under 18) applicants cannot travel to TRNC unaccompanied, one of the parent / grandparents / siblings / relative / neighbours (Any adult) with whom they are travelling with, must provide thier valid work/study/residence Permit. In case the adult accompanying traveller is not a parent, their details (passport number, name and relationship with applicant) must reflect in the Notarized invitation.	
17.	If an authority letter, NOC or power of attorney is issued by a parent residing in in Turkish Republic of Northern Cyprus authorizing an accompanying person for their minor child, the document must first be approved and attested by the Ministry of Foreign Affairs, Turkish Republic of Northern Cyprus. If one parent is in Pakistan, they must personally submit a notarized consent letter to Anatolia Visa Application Center.	
18.	Polio Certificate/Card both are acceptable. (either of these).

20.	Medical Report/certificate must be valid for 03 months from the applicants test date at the Labs.	
	Note: 1. Once the visa exemption letter is approved, applicants must apply for Türkiye transit visa. After complete Türkiye transit visa process, original visa exemption letters will be given to the applicants. 2. In case of refusal, applicant can apply again after 06 months from the date of refusal. 3. After MOFA attestation, applicants must verify that the QR code affixed by MOFA, when scanned, displayed the correct document on the MOFA website. Any discrepancies must be rectified before visiting Anatolia centers for application submission.
