

Guidelines for Türkiye Umrah Transit Visa

Acceptance of Türkiye Umrah Transit Visa Applications:

Visa applications for Türkiye Umrah Transit Visa are now accepted at Anatolia offices across Pakistan. However, following eligibility criteria shall apply;

1. Applicants those who got refusal for any visa category during last 3 months, are not eligible to apply for “**Umrah Transit Visa**”. However, they can apply for visa for rest of the visa categories.
2. Applicants have to provide all Tourism purpose documents mentioned on the checklist with addition of Umrah E-Visa copy.
3. Confirmed returned air ticket only from Turkish Airlines is mandatory. Applicants should apply at least 30 days before their travel date.

Biometrics Requirements:

Applicants aged 12 years and above are required to personally appear for biometrics.

Application Jurisdiction:

When applying for the Umrah Transit Visa to Türkiye, please follow these guidelines based on your current place of employment or business operations:

Islamabad / Rawalpindi / KPK and AJK Residents: If you are working or conducting business in Islamabad, Rawalpindi, KPK or Azad Jammu and Kashmir (AJK), you should apply for your Türkiye visa either from Visa Application Centers in Islamabad or Peshawar, regardless of your residential address, CNIC, passport details, or bank account location.

Punjab Residents: Applicants physically employed or engaged in business within any city of the Punjab province must apply for their Turkey visa solely from the designated Punjab Visa Application Centers (Lahore, Sialkot, Faisalabad, or Gujranwala).

Hazro, Kamra, Attock, Chakwal, and Mianwali Residents: If you are working or conducting business in Hazro, Kamra, Attock, Chakwal, or Mianwali, you have the flexibility to choose between applying for your Türkiye visa either from the Visa Application Centers in Islamabad or Punjab.

Sindh and Balochistan Residents: Applicants physically engaged in employment or business activities within Sindh or Balochistan Provinces are required to apply for their Türkiye visa either from the Anatolia Visa Application Centers in Karachi or Hyderabad.

We appreciate your cooperation in adhering to these regional jurisdiction guidelines for Türkiye Umrah Transit visa applications. Please ensure that you submit your application to the appropriate Visa Application Center based on your place of work or business.

Türkiye Umrah Transit Visa Options:

Türkiye Umrah Transit visa is exclusively for “**Single Entry**” and duration of stay is maximum for 7 days. However, it is the sole discretion of the Embassy/Consulates to extend you either 7 days or less than 7 days duration of stay.

Processing Time:

The processing time for Türkiye Umrah Transit visa is generally of 30 days, though this may vary.

Visa Fees:

Visa fee is exempted exclusively for the Türkiye Umrah Transit visa. However, other charges including insurance fees, service fees, and any VAS (Value Added Services) are applicable according to the exchange rate announced by the State Bank of Pakistan from the previous day. Please note that all fees and charges are non-refundable. All applicable charges to be paid in cash PKR at Anatolia Visa Application Centers.
